#### **IRA Charitable Distribution**

If you are age 72 or better you can make a tax-free gift by instructing the Trustee of your IRA to transfer the withdrawal directly to a charity. While not tax deductible, the funds transferred from your IRA to a charity count toward your RMD and you do not incur any federal income tax liability. Talk to your financial advisor. Be sure to tell your trustee to include your name and indicate it is from an IRA so you can be issued a correct receipt.
